PUBLIC SPEAKS

Shawn Lynch, Bolivar Fire Chief advised they distributed 41 smoke detectors and letters will go out to area businesses next week seeking donations to purchase more smoke detectors to distribute. Lynch advised American Red Cross is also distributing smoke detectors but concentrating in the Newcomerstown area due to recent fire tragedy. Lynch advised trustees they are working with manufacturer regarding some paint issues with the new fire truck, which has a 7-year paint warranty.
